Authorized National Safety Council Sub-Agencies must agree to return leased training materials upon termination of said Agreement or pay fees for lost films. **See reverse for prerequisites and other requirements.**

### **ALIVE AT 25 DEFENSIVE DRIVING INSTRUCTOR DEVELOPMENT COURSE INSTRUCTOR REQUIREMENTS**

1. Possess current certification in the National Safety Council's Alive at 25 Defensive Driving 4-Hour Course (provided during the 3-day the Instructor Development Course.)
2. Successfully complete the National Safety Council's Alive at 25 Defensive Driving Instructor Development Course (3 days).
3. Be monitored by an Instructor-Trainer for at least 2 probationary classes.
  - a. Monitoring fee and travel extra.
4. Maintain biennial (2-year) Agreement (contract).
  - a. Private Sub-Agency Agreement authorizes training of company employees only, at any company location, world-wide. Public Sub-Agency Agreement authorizes training of anyone within set territory (i.e. 23 parishes in Louisiana). Agreements must be approved prior to Instructor Development Course. Contact local Chapter or nearest NSC Office for further details.
  - b. Public Sub-Agency Agreement includes non-compete restriction.
5. NSC membership required for Public Sub-Agencies and is optional for Private Sub-Agencies.
  - a. Annual dues are based on the average number of full-time employees and begin at \$270. Membership information available upon request or visit [www.metrosafety.org](http://www.metrosafety.org) or [www.nsc.org](http://www.nsc.org). Dues may be tax deductible.
6. Each instructor must teach a minimum of two Alive at 25 courses per year.
7. Purchase/lease all required NSC training materials from local Chapter or NSC Office:
  - a. Alive at 25 Teaching Kit with first year film lease (\$402\*). Includes English/Spanish DVD or VHS videos (6 titles) and PowerPoint presentation on CD.
  - b. Annual renewal of lease (\$150\*).
8. Purchase course guide for each student. Available in English or Spanish (\$4.10\* each.) Minimum first order for Public Sub-Agency 50. Quantity discounts available.
9. NSC annual instructor recertification fee. (\$50\* per instructor.)
10. Agree to return original films to Chapter or NSC Office upon termination of Agreement or agree to pay fee for lost films. (\$800\*)
