## ***NSC FIRST AID & CPR (Standard or Pediatric)***

### ***INSTRUCTOR REQUIREMENTS***

1. Complete the First Aid Training Center and Instructor Agreement.
  - a. If teaching only your company employees, also complete the Private Training Center Agreement.
  - b. If teaching at an educational institution, also complete the Educational Training Center Agreement.
  - c. If teaching outside the US, also complete the International Training Center Agreement.
2. Attend an Instructor Development Course or be “Grandfathered in” as an instructor.
  - a. Attend 3-day National Safety Council’s First Aid, CPR & AED (Standard or Pediatric) Instructor Development Course. (See reverse for dates, times, cost.)
    - i. Be monitored by NSC Instructor-Trainer (IT) from local Chapter for at least 2 classes. Monitoring fee extra.
  - b. If you possess current First Aid, CPR & AED teaching credentials, you may qualify to be “Grandfathered in” as an instructor without attending an Instructor Development Course. (Call your local Chapter for details.)
3. Purchase all required NSC training materials from local Chapter, including:
  - a. Instructor Resource Kit, which contains instructor manual, DVD, instructor CD-Rom, Student workbook. (One per instructor. For Private Training Centers, one per instructor or one per location.) One kit is included in cost of Instructor Development Course.
    - i. First Aid Only #73142-0000 (\$125\*) or
    - ii. First Aid, CPR & AED #73131-0000 (\$125\*) or
    - iii. CPR & AED Only #73137-0000 (\$125\*) or
    - iv. Pediatric First Aid, CPR & AED #73157-0000 (\$125\*)
  - b. Student Manual. (One issued to each student for each class.) Includes certificate(s).
    - i. First Aid #73143-0024K (\$9.50\*) or
    - ii. First Aid, CPR & AED #73132-0024K English / #73163-0024K Spanish (\$11.95\*)  
or
    - iii. CPR & AED #73138-0024K (\$9.50\*) or
    - iv. Pediatric First Aid, CPR & AED Plus (for LA daycares) #73198-0000K (\$12.95\*)
4. Submit rosters online via FA Instructor Portal.
5. Pay yearly NSC Instructor renewal fee (\$40), which is waived for the first year.

NOTE: Manikins, AED trainer, bandages, splints, etc. may be obtained from any source.

\*Prices and other restrictions may vary from other NSC Chapters. Shipping and handling are extra. Prices are subject to change without notice.
